Old Business

Policy Approvals

- GCBDA - Short Term Leaves Certified - The policy is updated to match the negotiated agreement.
- GDBDA - Short Term Leaves Classified - This policy is updated to match the negotiated agreement.
- JCB-AP2 - Interdistrict Transfers - This policy creates a single date for determining if a student can transfer. All interdistrict transfers will now be decided on August 1st.
- JGA - Corporal Punishment - this updates the "Note" section of the policy
- JGGA-AF1 - Seclusion and Restraint - This form is updated to align with the reporting requirements of a new state law.

22-23 Staffing Plan

Two additional teaching positions have been added for next year. One position is for the high school due to increased enrollment at the high school and the other position will be used if enrollment exceeds expectations.

New Business

A memorandum of understanding between the district and Care to Learn was approved. The total cost to the district is \$1,500.
