## New Business

The 2023-2024 academic calendar was approved. [Here is a direct link to the calendar.](#)

Budget Amendment #1 was approved. This updates the budget to what has already been approved earlier in the year. The new projected operational ending fund balance for the 21-22 school year is approximately 28%.

Approximately 25% of the paraprofessional positions are currently vacant. In an effort to address the shortage, the board of education allocated \$100,000 to go toward paraprofessional stipends for this school year. These funds are currently budgeted for paraprofessional salaries, but are going unused due to the vacant positions. Specific requirements on how paraprofessionals can earn this stipend have not been developed. The district will send out communication directly to
