Prop R3 Ballot Language

The ballot language for Prop R3 was approved. The language that will appear on the April 2, 2024 ballot will be:

Shall the Board of Education of the Warren County R-III School District, Missouri, without an estimated increase in the current debt service property tax levy, borrow money in the amount of Forty-Five Million Dollars (\$45,000,000) for the purpose of providing funds for the site development, construction, equipping, and furnishing of a new elementary school and other building additions; to upgrade heating, ventilation, and air conditioning (HVAC) systems; to repair or replace roofing; to acquire land and buildings; to prepay capital facility lease obligations issued to finance construction and capital projects; to the extent funds are available, complete other renovations, repairs and improvements to the existing facilities of the District; and issue general obligation bonds in different years or different amounts as determined to be in the best interest of the District as long as the aggregate amount does not exceed the Forty-Five Million Dollars authorized for the payment thereof?

If such general obligation bonds are issued, the adjusted debt service levy of the School District is estimated to remain unchanged at \$0.6503 per one hundred dollars of assessed valuation of real and personal property.

Long Term, Permanent, and Teacher Certified Sub Pay

Substitute teacher pay for those that hold or have held a teaching certificate, permanent substitute teaching positions or long-term substitute teachers will now be paid \$180 per day.

Fencing Bids

Kennedy Fencing was approved to install fencing for the Alpha Academy, Warrior Ridge, and Daniel Boone. The total cost is \$51,935. This will be paid for out of safety grant funds.
